About the Project

The Borumba Pumped Hydro project is a 2,000 MW pumped hydro energy storage system at Lake Borumba, located in Imbil, west of the Sunshine Coast.

It forms a critical part of the Queensland Government's commitment to transitioning to 80% renewable energy by 2035.

About the ROI

With over 2,000 workers expected during peak construction, the Borumba Pumped Hydro Project will have a meaningful impact on regional communities and will continue to build diverse local economies.

While this will bring significant long-term benefits, we understand that this comes with disruption for the local accommodation market already experiencing shortages and constraints. As a good neighbour, we recognise that it is our duty to help address these challenges.

To ensure sustainable, long-term solutions, we have opened a Registration of Interest (ROI) for locals living within the Borumba Project footprint to provide input on the development of our Accommodation Strategy.

We're hoping to gather early information on the state of play on accommodation in Project area, in Sunshine Coast, Somerset and Gympie Regional Council areas.
